

# GET'N LENA

## Breeding Agreement

Between Wayne Williams of 1252 Neurum Road, Woodford Qld 4514 being the Stallion Owner and

.....AQHA # .....

of .....

being the Mare Owner wish to breed our mare by Natural  Or A.I.  (Please select)

1. It is agreed that the Stallion Owner shall breed **Get'n Lena** Reg. AQHA **Q-58108** to the Mare:

.....Reg. No .....  
for the 2009 breeding season at a Service Fee of \$1100.00 (\$1000 plus GST of \$100.00)

2. A non-refundable Handling Fee of \$440.00 is payable on the signing of this contract.

3. The balance of \$660.00 shall be payable within 7 days of the mare's positive pregnancy test or when she is collected from the nominated Breeding facility, whichever is sooner (14-42 days). In the case of A.I. the full service fee is payable prior to collection.

4. Standard agistment fees and conditions apply while the mare is in the care of Wayne Williams or his employees.

5. The Mare Owner shall return the Breeding Agreement duly signed together with a copy of the Mares registration papers. The Stallion Owner shall sign the same agreement to form a binding agreement and return a copy to the Mare Owner.

6. The Mare Owner shall be entitled to a live foal guarantee with return privileges in the following season on the following conditions:

- (a) fails to settle
- (b) does not conceive in the 2009 season; or
- (c) if the foal is absorbed, aborted or does not stand up and nurse;

7. The Mare Owner shall be entitled to a rebreed the following season.  
In order to qualify for the return privilege as set out above the following should be observed:-

- (a) If the foal has died, a certificate is required by the Stallion Owner in writing from a Veterinarian within 7 days of the date of the death.
- (b) In the case of embryo transfer, the recipient Mare must have remained at the nominated Vet Centre until it receives a 42 day positive pregnancy test.

8. If the Mare Owner fails to make arrangements for re-breeding the mare in the following season, the return privilege is lost and the deposit forfeited. There is no live foal guarantee in the following season.

9. Should the Stallion die or become unfit for service, the Handling Fee will be refunded.

10. A Breeding Certificate will be issued after the 42 day positive pregnancy test and after all monies due

under the agreement have been paid.

- 11. All accounts overdue will be charged interest at the rate of 1.5% per month.
- 12. The Stallion Owner may agree to a transfer of the Agreement should the named Mare be sold, or to a substitution of the named Mare should the named Mare die or be unable to breed. Otherwise this agreement is not transferable and applies to the named Mare only.

**A.I. Services**

First collection will be at the Stallion owner’s expense if AI is selected. Free collection is not offered after natural service has not been successful. Second & subsequent collections will be \$275.00 (inc. GST) and will be at the Mare owner’s expense. Freight for shipping the semen and the return of the semen shipper is not included and is payable by the Mare owner/s.

Mare owner/s shall advise the Stallion Owner when the mare is due to come in season. At least one week is required to have a mare available for semen collection. Also required are the shipping details of where, whom and how to send the semen.

Mare owner/s to supply a certificate, signed by the veterinarian responsible for inseminating the mare, that only one mare was inseminated with the chilled or frozen semen.

If the mare fails to go in foal, a signed certificate from the veterinarian handling the mare, to state that she did not conceive will be required before a second collection is dispatched.

It is the Mare owner/s responsibility to use a qualified veterinarian or registered breeding centre to perform the insemination of the mare.

If the Mare fails to go in foal after a maximum of four attempts then the service fee will be refunded. Note that the handling fee is non-refundable.

Service fee and collection costs must be paid in full before semen will be collected and shipped.

Service certificate will be forwarded once advised that the mare is tested in foal.

This agreement and any dispute arising under it shall be decided according to Queensland Law.
